

Report Item 3: Securities Holders

The voting power is National Bank & Trust as Trustee; except for re-organization and stock issuance

Trustee to Vote Shares of Company Stock; Exceptions. All Company Stock in the Trust shall normally be voted by the Trustee in such manner as it shall determine in its sole discretion. However, with respect to any corporate matter which involves the voting of Company Stock as to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transactions as may be prescribed in Code regulations, each Participant will be entitled to direct the Trustee as to the exercise of any voting rights attributable to shares of Company Stock then allocated to his Company Stock Account but only to the extent required by Code sections 401(a)(22) and 409(e)(3) and Treasury Regulations. In that event, any allocated Company Stock with respect to which voting instructions are not received from Participants shall not be voted, and all Company Stock which is not then allocated to Participants' Company Stock Accounts shall be voted in the manner determined by the Trustee.
