The Board of Governors of the Federal Reserve System has published a new pamphlet for Regulation H (*Membership of State Banking Institutions in the Federal Reserve System*), effective September 17, 2001.

Also, slip-sheet amendments have been published for Regulation B (*Equal Credit Opportunity*), the Official Staff Commentary on Regulation B, Regulation M (*Consumer Leasing*), the Official Staff Commentary on Regulation M, Regulation DD (*Truth in Savings*), and the Official Staff Commentary on Regulation DD.
